III. Nội dung đề bài

1. Đề bài

A seller whose place of business is in Vietnam and a buyer whose place of business is in China entered into a sale of rice contract on 25 November 2020.

Q1. The Vietnamese seller sued the Chinese buyer in a Vietnamese court as the buyer failed to make payments in full. Decide applicable laws to settle the dispute given that

the choice of law clause in the contract as follows: 'The applicable law for this contract is Incoterms® 2020'.

Q2. Although the contract is silent on the penalty clause, the seller claimed that they are entitled to penalize the buyer. The penalty should be 8% of the goods involved in the late payment. Decide if the seller could claim for penalties.

Q3. The Chinese buyer claimed that they failed to make payments due to the effect of Covid-19 that prevented them from reselling rice to other customers in Europe. Could the seller be exempted due to the Covid-19 pandemic?

Q4. The Chinese buyer also claimed that they failed to make payments because the Vietnamese seller delivered non-conforming rice as stipulated in the contract. Consequently, the buyer declare the contract avoided. Decide if the buyer could claim for the avoidance of the contract.
